Dear Mr. Shorten,

Further to Mr. Tinkler's letter of 26th March I am disappointed that you were unable to scrutinize Mr. Madden's role in the unreasonable and unnecessary demolition of the Kew Cottages' facilities, as requested in my letter of 5th June 2009.

Thank you, however, for raising this matter with the Victorian Minister for Community Services, Ms. Lisa Neville.

According to Hansard, hundreds of families were stuck on the Waiting List for Respite Beds in Victoria as at 30 June 2009.

In the Eastern Region alone I understand 118 families were still waiting for Respite Beds (see attached).

It would appear, therefore, that over half (60) of these families could have been offered access to respite beds if the very high quality Kew Cottages facilities had not been suddenly decommissioned and demolished in March 2009.

Mr. Tinkler makes no mention of your receiving any advice on the Respite Care Waiting List details in his letter, our understanding, therefore, is that you must have been kept unaware of the significant shortage of Respite Beds in Victoria.

We will shortly be updating our own website (www.kew.org.au) with details of these issues, including the 4 Corners ABC-TV program Breaking Point , so please let me know if there is anything else you would like us to have regard to besides the points made in Mr. Tinkler's letter.

In the meantime I would urge you to review the options available to you to undertake a more effective response to Respite Care Waiting Lists in Victoria, and particularly to the 'financial black hole' for the intellectually disabled that has been allowed to develop at Kew Cottages.
